SheAI

Stephany Oliveros is a psychology researcher investigating the impact of AI in cognition and human behaviour. She has studied medical physics and started to gain interest about AI 5 years ago. She has worked as an AI product manager for companies including a LLM trained in healthcare data and in legal tech creating AI agents specialised in law. Now she is the co-founder of SheAI, an educational platform that looks to close the gender gap in AI literacy with a learning female-first community and corporate training in collaboration with United Nation's AI for Good coalition. She has been guest speaker at the biggest conference on technology of Europe (Mobile World Congress) and her project has been featured in multiple news outlets. She is interested in inspiring women to contribute to ethical and responsible AI innovation.




Lea Maria Schäfer

Lea Maria Schäfer is a doctoral candidate at Charité Berlin, researching the integration of AI in psychotherapy with a focus on chatbot interaction, conversational AI, and large language models (LLMs). Her work explores both the challenges and opportunities of AI in mental health care, asking what a responsible and effective implementation could look like. She holds a degree in Science and Technology Studies from the Netherlands and later studied Psychology in Germany. Lea is currently training to become a clinical psychologist at the Berliner Akademie für Psychotherapie and conducts her doctoral research under the supervision of Dr. Stephan Köhler. Lea combines academic research with real-world application through her work at clare&me, where she has been part of the team for over three years. As Head of Psychology and Chief Scientific Officer at the Synthetic Therapy Lab, she leads the development of clinically grounded, ethical AI tools for mental health. With a background that bridges technology, psychology, and clinical practice, Lea is driven by the question of how AI can support—not replace—therapists, aiming to improve access while preserving the human essence of psychotherapy.


Adam Dicko
